3) Threats to the West Brochure – Karen

Brochures are printed and delivered. Thanks to everyone who worked on it. Should have folks who are printing their own, tell us how many they printed. Joanne to send follow-up email to folks who placed orders to ensure they received them.

4) NISAW/Hill Visits Follow-Up- Stephen/Tom

Some attendees (Ted Thayer and Julie Reegan of Tahoe) went back to Washington for a briefing to discuss funding for future years for state plans, Lake Mead and other issues. Fair number of Congressional staffers attended (CA, WA, OR & NV). The group meets again next week, so we'll know more then.

5) Ballast Tanks Letter and Update - Elizabeth/Stephen

Ted Thayer put together conference call with watercraft manufacturers and watersports folks. They had a great conversation. One of the manufacturers designed a filtering system based on information exchanged during call. Stephen passed first round for funding to BPA Tech Innovation Fund with Univ of Reno to test system at Lake Mead. Manufacturer to build 30 test units to send to Lake Mead.

6) WRP Coordinator RFP- Joanne

Plan moving forward is to work with existing committee to screen applicants. ExCom approved latest draft RFP to post for competition.

7) WRP Letter to States Re Funding- Kevin

We need to wrap it up. ExCom approves as written. Karen will send out to membership on Monday. Any additional edits need to go to Karen before then.

8) ANSTF Letter - Karen

Susan Mangin drafted letter to NISC based on WRP recommendation in October meeting. ExCom members generally agreed with letter with a couple of minor edits. Group to get comments to Karen by COB Monday; these will be compiled and returned to Susan.

9) WRP Recommendations for May ANSTF meeting - Joanne/Karen

ExCom members approved the list of recommendations as drafted. Larry Dalton will be representing WRP at this meeting.

10) Assistant Attorney General Workshop - Joanne

Committee moving towards a workshop in Aug/Sept in Phoenix to address legal components of boat movements. Invitees will include state and federal Assistant Attorney Generals, Law Enforcement Supervisors and AIS Coordinators. Funding to support workshop will come from National Sea Grant Law Center, NSG and USFWS. Group meets next Tuesday at 11:30 am MT to work on development

11) Committee reporting update - Karen

Karen working on template. We have some question about how to count folks working on ANSTF work groups and WRP representation.
