- A) Approval of May minutes. Dennis moves to approve, John seconds. All in favor. Minutes approved.
- B) Panel Business
 - QZAP 2.0 Action Items: review of objectives for progress. Section D was reviewed. For the next meeting Leah will compile all follow-up items that could be queried by survey to membership etc. to share with Ex Comm. Next review will begin in section E.
 - Address suggested edits to the Wildland Fire Decontamination document. ANSTF
 Prevention subcommittee provided minor comment to address basic information on
 veligers for the reader. To be continued, once we hear from the subcommittee then we
 may anticipate approval from ANSTF possibly.
 - Ex Comm election 5 seats open for election. Announce after July 4^{th.}
- C) Legislative update Stephen Phillips
 - Sen Bennett introduced BOR cost share bill similar to previous ones. This bill is related bill is the Manchin bill, however both have the language that mentions that waterbody inspectors may not be present but launching is still allowed.
 - The appropriations process for 2024 is underway. Because of the dept limit agreement congress needs to get a budget done or there is a 1% mandatory cut. Already in the proposed APC-WID, the WID has been reduced from \$17M to \$7M. This cut may have come because in previous years, the funds have not been spent fully. Several of the other basins are nearly complete and will be tapping into the APC-WID funds very soon. There is a possible funding "earmark" that has been submitted for the Metlakatla Indian Community to manage European green crab.
 - There is an effort to break NOAA away from the Department of Commerce which is unlikely.
- D) WRP Standing Committee Roundtable for Chairs/Liaisons
 - Annual Meeting Committee Leah Elwell; Leah will launch the registration early July. She gave a full overview of the current draft agenda which also will be released soon once some of the speakers are confirmed. Several sponsors have confirmed and provided funds. Leah will continue to solicit and query for support for the meeting. The announcement to host for the 2024 annual meeting will be released shortly. At the last meeting Kansas mentioned that they might be interested in hosting.

Lots of coastal related activities are going on outside of committee efforts, but there are several committee project items to be finalized related to biofouling.
